



## URSULINE ACADEMY 2026-2027 TUITION, DEPOSIT, AND FEES

TUITION.....\$32,850

**NON-REFUNDABLE FEES:**

<b>Enrollment Deposit</b>	\$1,000	Non-refundable deposit required to secure a seat for the next academic year. The deposit is applied against the tuition balance due on your FACTS account.
<b>Senior Fee</b>	\$550	Non-refundable fee charged to each senior to defray the cost of senior activities and graduation expenses (including graduation dress and gloves)
<b>Registration Fee</b>	\$500	A one-time, non-refundable registration fee assessed to new students at the time of initial enrollment.
<b>Payment Plan Service Fee</b>	\$50 / \$100 / \$150	2 / 4 / 10 payment plan - a fee charged to your FACTS account based on installment plan.
<b>Late Payment Fees</b>	\$125 / \$60 / \$25	2 / 4 / 10 payment plan; applied 30 days after the due date, per late payment.
<b>Returned Check / NSF Fee</b>	\$30	Charged for each returned check or insufficient fund (NSF) transaction.
<b>Tuition Refund Plan (TRP)*</b>	1.2% of net tuition	Enrollment in the TRP is <b>required</b> of all students, except for those who elect to pay tuition in one installment, where your enrollment in the TRP is optional, though highly recommended.  <b>Note:</b> The TRP policy begins annually on July 1 <sup>st</sup> .

**TUITION PAYMENT OPTIONS:** Ursuline Academy offers several tuition payment plan options via automatic deductions or credit card payments through our partner, FACTS Management Company.

**TUITION REFUND POLICY\*:** Tuition and fees are not refundable after June 1, 2026. For withdrawals after June 1, 2026, families are responsible for the entire year's tuition (less any tuition assistance and scholarship) unless the Tuition Refund Plan (TRP) was purchased and applies. The TRP policy begins July 1<sup>st</sup>. Withdrawals for medical reasons are covered effective July 1. Withdrawing for any other reason may be covered provided the student is withdrawing from Ursuline after attending more than 14 consecutive calendar days from the first day of school.

**OTHER COSTS MAY INCLUDE:** uniforms, books, iPad, transportation, Advanced Placement Exam fees
